



NOTICE OF PROPOSED SOLE SOURCE PROCUREMENT
this is not a competitive bid/proposal

The Utah Transit Authority (UTA) Procurement Policy provides that sole source procurements may be used only when the Award of a Contract is infeasible under other source selection methods, and at least one of the following circumstances applies: (a) The required goods or services are of a specialized nature requiring expertise that is only available from a single source; (b) The public exigency or emergency for the required goods or services will not permit a delay resulting from competitive solicitations; (c) After solicitations of a number of sources, competition is determined inadequate.

The UTA Purchasing Department has received a request to make the following sole source procurement:

Product and/or Service to be purchased: Compressed Natural Gas (CNG) Refueling Station Operations, Monitoring, and Maintenance Services Support.

Contract Duration: Twenty-Four (24) months ARO

Proposed Sole Source Supplier: Trillium Transportation Fuels, LLC (dba Trillium CNG)

Estimated Total: \$624,000.00

Sole Source Justification: Trillium CNG is the original manufacturer of UTA’s CNG Fuel Controls & Monitoring System and as such has the proprietary engineering drawings and original build specifications and manufacturing procedures. Trillium CNG utilizes smart station controls with proprietary software in order to connect to, remotely monitor, and manage UTA’s current fueling system that optimizes station performance. This software is solely owned, maintained, and supported by Trillium with no licenses issued outside the company. Substantial Duplication of Costs would occur where– the use of another source would result in the expenditure of significant additional funds or cause substantial downtime or delay due to required transition activities including retrofit, conversion, re-learning, re-tooling, or installation.
